Instructions for paying WV SAF registrations via PayPal

You will need a PayPal account to pay for a WV SAF registration. If you do not already have a PayPal account, go to PayPal.com and "sign up" for one; it is free to sign up.

Once you have a PayPal account, click on the "Send Money" bar at the top of the page. Enter the WV SAF email address associated with our PayPal account (wvsaf@yahoo.com) in the top box. Then indicate the amount you will be paying for registration in the second box and click "Continue". You should now be on the page where you enter your credit card information. At the bottom of the page are some text boxes where you can write notes to specify the type of registration you will be paying (e.g., member/non-member; extra banquet; etc.).
