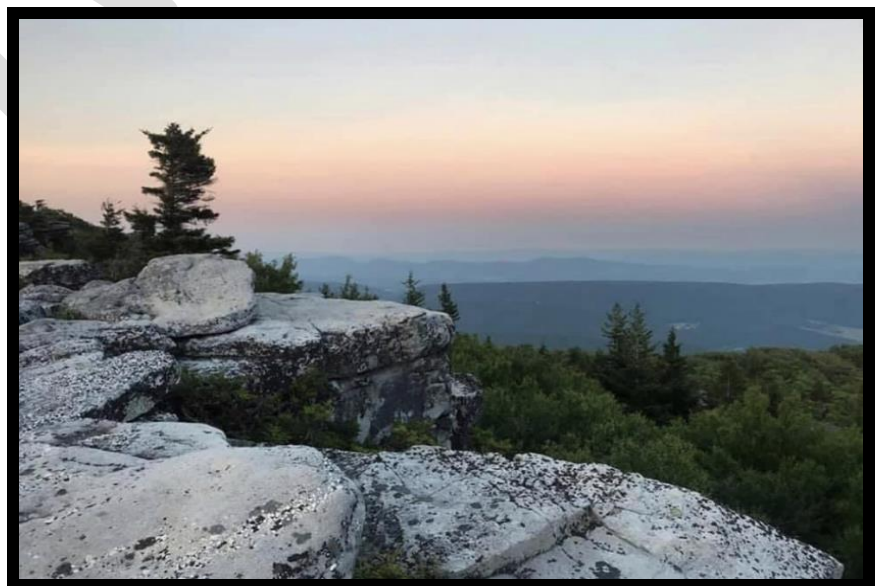

# Glenville State College Offers Online GIS Certification Program

The Online Certificate in Geographic Information System (GIS) will prepare students for work in the GIS industry with a focus on mapping, visualization, processing and analysis of geospatial data. Geospatial technology is a field that involves global positioning systems, geographical information systems and remote sensing. This technology offers an innovative way to combine information and maps to produce informational tools to help manage our communities, environment, natural resources and industries. The online Certificate program is designed for traditional students from academic departments other than the Department of Land Resources, non-traditional students and those who are already in the workforce to enhance skills, advance career and increase competitiveness to meet the challenges of working in this growing field or to continue their education within the geospatial and natural resource management disciplines. Faculty will work collaboratively with industry partners to develop hands-on projects and experiential learning that simulate real-world solutions to industry problems.

## **Benefits of being a Registered Professional Forester**

Part of the benefit of attending SAF meetings/training is the acquisition of CFE's needed to maintain your registration and/or licensing as a professional forester. In WV it is set out in H.B. 4447 30-19-6 (a) that registration is required "to use the title of "registered professional forester," "professional forester," "forester" or **other title connoting to the general public that the applicant is a registered forester qualified to perform professional forestry services.**"

## **West Virginia Board of Registered Foresters**

### **Position**

The WV chapter of the Society of American Foresters supports the structure & function of the WV Board of Registered Foresters. The WV chapter of SAF firmly believes that those who manage the state's forests, both public and privately owned, must be professionally qualified through both education and experience to fulfill their responsibilities. This includes a broad knowledge in the field of forestry and land management. These qualifications must be kept current through continuing education, experience and cross-training.

### **Issue**

Forester registration in the state of West Virginia is done through the WV Board of Registered Foresters. The independent nature of the board, by which a variety of interests within the profession are represented, is essential to provide balance in the requirements for registration in the state. The board provides an important function by ensuring that foresters are adequately trained and qualified to practice forestry. Forester registration provides an important service to forest landowners and the public by ensuring that individuals with inadequate training or skills do not misrepresent the forestry profession. Registration provides landowners with ability to hire professional foresters to perform various complex management task, such as timber harvesting, timber stand improvement, wildfire suppression, and wildlife habitat improvement on their property. Ultimately registration of forestry professionals protects the public, environment and natural resources in WV.

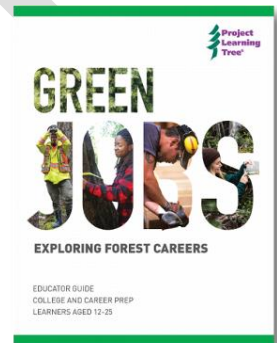

Students gain awareness of their surroundings. They learn to think critically and responsibly, and they learn to respect the opportunities our trees and forests provide, as well as the protection they require.

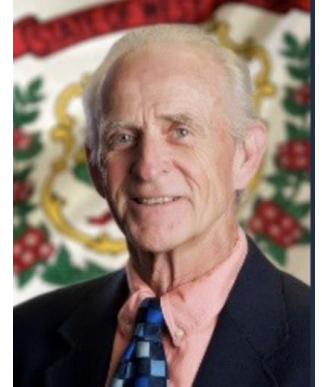


**Larry Barger** Larry S. Barger was born in Elkins in 1940. He earned a B.S. in Forest Management from WVU in 1966 and was a certified Wildland Firefighter from 1972-77. The U.S. Forest Service named him a Certified Master Estimator in 1982, a designation he alone held in West Virginia until his retirement in 1994. He began his career with the U.S. Forest Service in 1967 and held positions in Richwood, Petersburg, Bergland, Mich., and Elkins. In May of 1977, he transferred to the Monongahela National Forest Supervisor’s Office as the timber sales and mensuration forester. He was also the contracting officer and was responsible for training and certification of all the timber markers for the forest. After his retirement from the forest service, he started Barger Forestry Services, a consulting firm with more than 200 clients. During his first year of college, he planted 200 Christmas trees, an operation he continues. He also helps market Christmas trees produced by other growers. In 2018, the Society of American Foresters presented him with its Golden Membership Award, his 50-year affiliation with the organization. He is a member of Otterbein United Methodist Church, where he has served as finance secretary since 1979. He is Past Master of Elkins Masonic Lodge #108, belongs to other Masonic orders, and is a member of Elks Lodge #1135 in Elkins. He served as judge for the Mountain State Forest Festival Lumberjack Competition for more than 30 years.

## Barry Cook

Barry Lester Cook was born in 1949 in Williamson, where he graduated from high school in 1967. He earned a B.S. in Forest Management from WVU in 1971 and an M.B.A. from Duke in 1994. He began his career as Logging Superintendent for Weyerhaeuser Company in Plymouth, N.C., and then worked at J.P. Hamer Company. In 1978, he became procurement officer at Coastal Lumber, eventually becoming Vice President of Operations. He then became President of Forest Products Group and eventually purchased Indiana Hardwoods. He was appointed State Forester in 2017. As head of the state Division of Forestry, he orchestrated numerous initiatives to attract students to forestry programs and traveled to many national meetings and conferences to tout West Virginia's forest resources. He pushed for legislation to recognize the Division's foresters as emergency responders and provide them with appropriate benefits. He also organized a Division of Forestry Color Guard and Chaplain Program, among many other initiatives. He was known as an energetic, resilient and innovative leader who took great pride in promoting the state's forest industries and who worked cooperatively with his employees, colleagues and other state government agencies. He was chosen as the West Virginia Forestry Association Forester of the Year in both 2018 and 2020. He was a member of the Woodrow Wilson High School Athletic Boosters, the United Methodist Temple in Beckley and Antioch Baptist Church in Enfield, N.C.

## Mark Double Mark

L. Double earned a B.S. in Biology from WVU in 1974 and completed his M.S. in Microbiology in 1977. He began his career as a Research Assistant and Chemical Hygiene Officer at WVU. With a career spanning 41 years at the WVU Division of Plant and Soil Sciences and 60 publications to his credit, he is regarded as a meticulous researcher who has contributed significantly to the knowledge of Chestnut Blight and Oak Wilt. He served as Secretary of a USDA multistate Chestnut project from 1982- 2018 and produced proceedings of their gatherings. The project itself won three national awards of excellence in 1997, 2008 and 2012. He routinely gives talks to clubs and civic organizations throughout the state, and has given presentations at scientific meetings in Germany, France, Italy and Hungary. He has organized volunteers and overseen the distribution and planting of chestnut seedlings

through the state as a lasting legacy. He has injected elm trees at the historic Glenwood Estate in Charleston against Dutch Elm Disease every three years since 1982. He is President of the West Virginia Chapter of the American Chestnut Foundation (TACF) and started the chapter newsletter. He was the keynote speaker at TACF's 35th anniversary annual meeting in 2019 and was the recipient of the group's Outstanding Service Award in 1991. He has been active in the Rowlesburg Chestnut Festival, serving as chair of its science committee and as "Mr. Chestnut."

## *In Memoriam - WV SAF Members*

**Dr. Kenneth L. Carvell**, 70-year WV SAF member passed away on September 24, 2021. Dr. Carvell was born in North Andover, Massachusetts. From 1948- 1953, he earned a bachelor's degree in forestry, Harvard University; master's degree, Yale University; and doctorate in forestry, Duke University. Dr. Carvell came to West Virginia University in 1953 as Assistant Professor of Silviculture. His activity in service, teaching and research was voluminous. He was unselfish with his time to civic organizations, schools and other public groups. The Allegheny Society of American Foresters bestowed him the honor of Outstanding Forester. He also received the Outstanding University Teacher of the Year from WVU and Distinguished Service Award from the Society of American Foresters. His research in the area of silviculture and silvicides contributed significantly and added to the prestige of WVU's Division of Forestry. He helped WVU strengthen relationships with many of its clientele groups, most noteworthy the community of vegetation management professionals in the power utility industry. Of all his accomplishments and contributions, most remembered will always be his dedication to teaching and students. Generations of students remember him not only as a professor, but as a friend. Dr. Carvell took special interest in two important facilities of the Division of Forestry and gave considerable time and effort to their improvement. The first was the Forestry Library in Percival Hall. He worked hard to get donations of periodicals and publications to make the library a valuable asset to the Division's teaching programs. And, his work as overseer of the University Forest for many years was really a labor of love. Many students had the opportunity to work side-by-side with him in the forest on various management, research and improvement projects. Dr. Carvell has published more than 150 scientific and popular articles on topics related to forest ecology, tree care, vegetation management and the safe use of herbicide growth regulators. He is an active member of the Nature Conservancy, Izaak Walton League of America, Utility Arborist Association, Danforth Association, Society of American Foresters and West Virginia Native Plant Society. Dr. Carvell retired from WVU in 1988 as Professor Emeritus of Forest Ecology.



**Ralph P. Glover, Jr.**, 80 of Charleston, WV, passed away on September 7, 2021. Ralph P. Glover, Jr., was a native of Terra Alta, WV, who spent most of his adult life as a resident of Charleston, WV.

He received a bachelor's degree in forestry from WVU in 1962. Ralph then served in the U.S. Army. Most of Glover's career was spent with the West Virginia Division of Forestry. He served in several positions including Assistant State Forester for Fire Protection, Deputy State Forester, Acting State Forester and Deputy Director during his 30+ years with the Division.

Ralph was extremely active with the WVU Division of Forestry Alumni Association serving as the past-president. More impressively Ralph has served as treasurer for the Association for over 40 years. Glover currently serves as a member of the board for the WVU Forestry Endowment Fund. He was selected the outstanding alumnus in 1994.

Because Ralph received a scholarship while attending WVU, he chose to create the endowed Ralph Glover Scholarship which is awarded to undergraduate students in WVU Davis College of Agriculture, Natural Resources and Design's Division of Forestry and Natural Resources. Ralph also established a similar scholarship in memory of his late wife who was a nursing student at WVU.



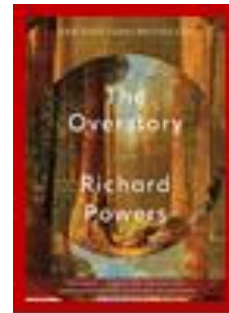
## ***BOOK REVIEW***

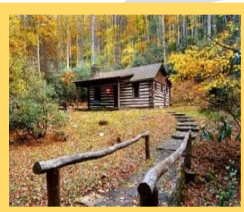


## For Sale - "West Virginia Logging" and "Forester at Home" Prints
