



# Chair's Corner

As I write this column, I am preparing to attend the SAF National Convention in Orlando, Florida. The convention should prove to be an outstanding event. I will be presenting the 25-year anniversary of the Roach-Bauer Forum sponsored by the Plateau and Northern Hardwood Chapters as an Allegheny SAF success story at the House of Society Delegates. It was also nominated for an HSD award for chapters. By the time you read this, I will know if it won or not.

It is also <u>election time</u> in Allegheny SAF. We have an excellent line-up of candidates running for office and I hope that you will all vote. We also have revised the Allegheny SAF bylaws to be in concordance with the new National SAF model bylaws for state and multi-state societies. Those changes are published in this issue of the Allegheny News along with a ballot for you to approve or disapprove them. Please return your ballot to the Tellers Committee. In addition to the elections, please take some time and think about whom is deserving of an award and then take the time and nominate them for the Allegheny SAF awards.

The picture with this issue's column shows me with a Persian walnut tree that is 250 or more years old. This tree is located in Kyrgyzstan, where the largest remnants of the

walnut-fruit forests of Asia are present. This unique forest is the center of origin for Persian walnut, pistachio, almond, apricot, apple, pear, cherries and plums. In 2005, I was fortunate to be able to provide a technical assistance visit to this forest to examine the damage done to it by gypsy moth. The trip was funded by USAID and was coordinated by their Farmer-to-Farmer program. Many of the Kyrgyz people gather fruit and nuts from the forest for both food and for cash crops. An extremely long gypsy moth outbreak is causing severe yield losses in pistachio in particular. As one of their few export crops, gypsy moth has created economic losses that hamper the people's ability to survive. While gypsy moth is native to the area, changes in the land use, in particular overgrazing, has resulted in a shift in the predator population and changed the ecological balance. This shift was exacerbated by the collapse of the Soviet Union and the loss of the central control of resources by the communist government. While the Kyrgyz government still owns the forest and farmers rent parcels for grazing and fruit and nut gathering, the lack of effective controls is evident. Exchanges such as this are critical to both sides as we learn about not only the forest systems but also the cultures. Familiarity goes a long way to reduce the world's problems and issues. I heartily encourage anyone to participate in these types of exchanges, either as a traveler or a host.

# In Memoriam: Henry Clay Smith

Henry Clay Smith passed away unexpectedly on August 15, 2009. He was 70 years old.

Clay served for many years as the Principle Silviculturist and Project Leader at the U.S. Forest Service, Northern Research Station Timber and Watershed Laboratory. Born in Piedmont, West Virginia, Clay received a B.S. in Forestry from West Virginia University in 1961, and a M.S.F. in 1962 from Purdue University; he also studied at Syracuse University.

He joined the US Forest Service in 1962 at Parsons, WV, and served his entire career there, except for a



four year stint in Burlington, Vermont (1967-1971), retiring in 1994. Clay's research on reproduction, growth and development of quality Appalachian hardwoods focused on practical management guidelines for forest managers and landowners. Particularly notable was his work on crop-tree management, grapevine control, and his contributions to the award winning "Managing Your Woodlot" video series.

After retirement, Clay maintained an active interest in forestry and was a practicing landscaper, forestry consultant, and wildlife photographer. An SAF member since 1961, Clay was an SAF Fellow, and a member of the West Virginia Agriculture and Forestry Hall of Fame, National Wild Turkey Federation, WV Christmas-Tree Growers, WV Forestry Association, and Woodland Owners of WV.

He is survived by his wife, Elaine, two sons Forrest and Eric, four grandchildren, and one great-grandchild. He leaves behind many friends and forestry colleagues who will remember his passion for the outdoors, a commitment to doing the right thing, and his ability to make each individual feel valued.

# In Memoriam: Manuel M. Gordon

Manuel (Manny) Gordon died July 23, 2009 at the age of 97. He was an SAF member for 74 years, having graduated with a BS in Forestry from Penn State University; he was one of its oldest living alumni. Manny was employed by the PA Bureau of Forestry as Lackawanna District Forester, overseeing the forests of Lackawanna, Luzerne, Wayne, Wyoming, and Susquehanna counties until his retirement in 1979.

During the Great Depression, Manny was in charge of the Civilian Conservation Corps (CCC) in NE Pennsylvania, and served in the US Army, overseeing prisoner-of-war forestry camps in France during the second World War.

Manny was most recognized for his television work with WNEP, Channel 16, where he urged everyone to get outdoors and "Enjoy, Enjoy!" Northeastern Pennsylvania. He had an amazing attitude and lived each day to the fullest. Manny's exuberance for life was recognized when he received the unique honor of having both the Manny Gordon

Recreational Site in Lackawanna State Park and the Manny Gordon Pond in McDade Park in Scranton named after him during his lifetime.

Involved actively in multiple civic, religious, and environmental organizations, he was an Eternal Light member of Temple Israel, Jewish War Veterans, and Shriners. Other civic interests included the Wyoming Valley Alcohol and Drug Services, Muscular Dystrophy Telethon and St. Joseph's Center.



# In Memoriam: Kenneth D. Swartz



**Kenneth D. Swartz**, age 73, of Chambersburg, PA, died June 15, 2009 after a courageous battle with lung cancer for over five years. He was retired from the PA Bureau of Forestry after working 40 years, having served as the District Forester of the Michaux State Forest since 1970 until his retirement in 1998.

Ken was a Life member of the PA Forestry Association, a Fellow in the Society of American Foresters, and held memberships in the Assoc. of Retired State Employees, National Wild Turkey Federation, NRA, Life member of the PA Forest Fire Museum Assoc. and a board member of Vision Quest. He was awarded the Distinguished Fellows Award from Penn State Mont Alto in June of 2008. He was a loving husband, father and grandfather who dedicated his life to the conservation of the forest resources of Pennsylvania.

# 2009 Annual Allegheny SAF Awards

Some time ago, I can recall my good friend Tim Holtz sharing the observation that it's a characteristic of a successful organization to give recognition for the accomplishments and service of its members. Time and experience have proven to me that Tim's opinions are most often correct, and always worth consideration. How does this anecdote relate to the Allegheny SAF? Here's how:

As you know, the Allegheny Society has established two annual awards, the Forester of the Year, and the Robert W. Bauer Outstanding Service to Forestry Award, to recognize individuals from among our membership who have made outstanding contributions to forestry and the Society. The purpose of the Forester of the Year award is to recognize current professional achievements in forestry and a specific accomplishment or achievement within 2009. The Robert W. Bauer Outstanding Service to Forestry award recognizes achievement in the forestry profession and service to SAF and local or regional community activities over a career time span. Last year, Kip Powers, of the MD/DE Division, received the Bauer award, and Steven Kallesser, of the NJ Division, was recognized as the Forester of the Year for 2008.

We all interact regularly with foresters who are deserving of our recognition for their professional commitment and performance. A request for nominations for awards will be forthcoming to Allegheny leadership later this fall. Please give consideration to professional peers who are deserving of our Society's awards, and forward their names to your appropriate Division or

Chapter Chairs for submission as nominees for one of the two annual awards.

Here is a brief review of how the award nomination and selection process works: Division and Chapter Chairs may submit nominations until the deadline of December 15, 2009. Nominations are received by the Awards Chair and forwarded to the Awards Committee. The committee consists of four members, one representative from each state Division in the Allegheny. To preserve the integrity of the awards peer review process, all members of the Awards Committee serve anonymously and individually; they conduct their ratings individually, not collectively; and no member knows who the other members of the Committee are. The Awards Committee members return their selections to the Awards Chair, who compiles the results, notifies the selected nominees, and co-presents the awards with the Allegheny Chair at the winter meeting awards banquet.

The opening paragraph of this article references the importance of recognition of performance to an organization and its members. I have served as the Awards Committee Chair for the past six years, and now am looking for an individual to succeed me in that position. If you feel motivated and interested to do so, please contact me (Howard Wurzbacher) or Mary Ann Fajvan to let one of us know of your interest.

Let's keep up the strong tradition we've developed by recognizing deserving colleagues through presentation of the annual Allegheny awards. Thanks!

# Bluefield WV Recognized Again as Tree City USA


Thanks to help from the members of the West Virginia Division Society of American Foresters, the City of Bluefield, WV received the "Tree City USA" designation for the 8th consecutive year. Tim Probert, Chairman of the Bluefield Tree Board and WVSAF member, participated in a tree planting ceremony to honor the city.

There are only 17 Tree Cities USA in West Virginia according to **Bob Radspinner**, member of the Tree Board and WVSAF. In order to be honored as a Tree City, a community must have an Arbor Day activity, have an ordinance in place to care for trees, have a \$2 per capita tree budget, and have a resolution supporting Arbor Day. **Andy Sheetz** of the WV Division of Forestry made the formal presentation to the City Tree Board.

At the closing of the presentation, Probert and other tree board members planted the flowering crabapple tree in Chicory Square. He added that, "the Tree Board has organized two community workshops and the group is working to develop a tree nursery in Lotito Park to establish 200 seedlings. Trees do a lot more than just sequester carbon and provide shelter for wildlife; they contribute a great deal to the quality of life in every community."

# PA Northern Hardwood Chapter Hosts Allegheny SAF Summer Meeting



exploration and production in the Alleghenies as well as the opportunity to renew personal and professional contacts.








# Allegheny SAF Executive Committee Meeting Minutes of July 22, 2009

# Minutes from the Previous Executive Committee Meeting

The minutes from the February 2009 Executive Committee meeting were approved.

# Treasurer's Report (R. Billingham):

A motion to accept the Treasurer's Report was made by K. Steiner and seconded by H. Wurzbacher. The treasurer's report was approved. Note that we are down \$2,779.25 in revenue this year from where we were at last year. R. Billingham also reviewed the information that was put into the ANSAF's 990-EZ tax form that was sent to the IRS for the 2008 tax year. This information was aggregated for ANSAF and all of its related divisions and chapters. If members are interested in receiving a copy of this information, contact R. Billingham at rbillingha@state.pa.us. R. Billingham is has almost finished the creation of a Treasurer's manual.

# **HSD Report (K. Gottschalk):**

Nominations for ththekk HSD division/chapter awards are due July 31. If any chapters/divisions want to send in nominations, send them in to K. Gottschalk soon. Note that activities need to have occurred in late 2008 or 2009 to be eligible for an award. If anyone has business items for HSD to consider, send them in to K. Gottschalk by mid-August. Congratulations to J. Winieski for 50 years of membership. The ANSAF 2009 Fellows are George Pierson and Robb Piper. The new ANSAF CFE Coordinator is Dave McGill (WVU Extension Forester). National has redesigned the website so that it is easier to navigate. State societies and chapters can have a page on the national website (right now, there is a link to our site). We may ask J. Purdue, our webmaster, to check into this option to decide whether we should use that resource or not.

# Executive Director's Report (J. Winieski):

There has been little change in the number of people receiving electronic newsletters. Plus or minus 200 are still sent hard copy for each electronic issue. J. Winieski and A. Day have been working on preparing the archives for their transport to the Penn State Archives. All except one box of records are now currently in order. The PSU Archivist will make the decision on what is archival and what is not. Note that records less than five years old are considered current (with the exception of financial records, which remain current for seven years). When Al Allison passed away, his widow called J. Winieski and asked if ANSAF would like his records. Someone from WV should contact her and see what she did with all the records he kept. We need to set up a procedure for archiving of our records. This procedure should require that records of six years or greater be sent to the Penn State Archivist for inclusion in our official record. R. Billingham will add this to the Treasurer's manual.

#### Nominations (K. Steiner):

So far, one candidate has accepted a nomination for chair-elect: R. Billingham. One candidate has accepted a nomination for Secretary/Treasurer: S. Resh. Four Executive Committee slots are needed. Regarding the Secretary/Treasurer position: we are working on a ballot measure to change the bylaws to allow the separation of the Secretary/Treasurer position into separate Secretary and Treasurer positions. We could have referendum this fall or spring and then follow that with a special election for the Secretary position next year. K. Gottschalk will complete the necessary preparations, which will include the new wording and a justification for the change. Note that nominations must be in to the National Office by Sept. 1, 2009.

#### Tellers (K. Gottschalk):

K. Gottschalk is still looking for someone to fill this position. We will need a committee in place before the upcoming election. We need to check with national on how to handle the paper ballots that need to be sent to members with no email access.

# Awards (H. Wurzbacher):

Francis Zumbrum was selected for the District 7 Presidential Field Forester Award. This will be H. Wurzbacher's last year as chair of this committee. He will help search for a replacement. Keep in mind that we always need nominations for awards.

# Membership (M. Fajvan):

We lost around 300 members during the purge. This is likely due to the economic situation in the country. Some of the individual chapters are taking hard hits in membership loss. National is running a campaign to invite non-members to convention and give them a free membership for a year.

# Forest Science Coordinator (M. Fajvan):

M. Fajvan will write one last article for the Allegheny News and then she will look for someone to appoint to this position. Eric Zenner, Silviculture Professor at Penn State, may be interested. M. Fajvan will contact him to find out.

# Program (N. Karger):

WV is in line to host next year's winter meeting. We do not have information on a location yet. Assignments for hosting meetings have been made through the winter of 2012. K. Steiner received some feedback via email indicating that this person felt that this summer's and last summer's meetings contained topics of no interest to him/her. The Executive Committee noted that attendance for both of these meetings was good and both received positive feedback. We should always do our best to make our program as interesting as possible to our membership; however, we realize that we cannot please everyone. We should continue to strive to show all sides of current/contemporary issues. We may, in the future, put out a notice that next host is looking for ideas. **By-laws (K. Gottschalk):** K. Gottschalk will send the revised by-laws to the National Office for assurance that they meet the minimum standards. The revised by-laws will then go to the membership for a vote.

# Fellows Process (K. Gottschalk):

There are some concerns surrounding the Fellows process, especially regarding what seems to be lack of communication to people whose nomination to Fellow were not successful. These problems are being addressed.

# Council Report (K. Gottschalk):

Council considering putting together a task force on biomass energy and its effects on forests. There are also several position statements up for renewal. NY and NE SAF have requested that Council instate a task force on high-grading and there has been discussion on whether this is needed or not – the FSTB says that there are several position statements that adequately cover this issue.

This will be a busy year for task forces, as Council intends to set up several. Among them are Forest Industry Competitiveness in the Global Environment and Woody Biomass Issues. Note that Charles Mann, author of 1491, is the Convention's keynote speaker.

ANSAF could send in written comments. The motion to do so was made by L. Casey and seconded by P Erikson. The letter will be written by M. Vodak and D. Tavella. These gentlemen will draft a letter and then send it to K. Gottschalk for signature. The motion carried.

M. Keefer: The 2008 Farm Bill requires each state to complete an assessment and strategy in order to qualify for federal funding. Pennsylvania would like feedback from SAF members. This will be a two-part process: 1. an assessment of what is happening in the forest and what the major issues are and 2. a strategy that includes how we plan to tackle the issues mentioned in the assessment. The state has not yet worked out all the details of how the feedback will occur. There will definitely be information on the website and documents for review. Stay tuned for more information.

An Open Letter to All Pennsylvania Division Members from Doug D'Amore:

I recently received correspondence from several members asking for a review of the Division's structure. Specifically the members asked that serious thought be given to reducing the number of Chapters within the Pennsylvania Division from the current number of seven (7) to a maximum number of four (4). The individuals felt that larger chapters will generate more attendance at local meetings, make finding officers easier and changes in transportation networks and communications have made larger geographical areas more logistically feasible.

# Referendum on Allegheny SAF Bylaws

The Allegheny SAF bylaws were in compliance with the minimum standard bylaws except for two major areas. A summary of the bylaws changes is given below. The proposed bylaws can be viewed on the Allegheny SAF website at <a href="www.alleghenysaf.org">www.alleghenysaf.org</a> in two formats – a "clean" version and a marked-up version that shows the additions and deletions (except for minor corrections). Please consult one or both of those documents for complete information.

# Summary of bylaws changes:

- Chairman was changed to Chair, and Vice Chairman to Chair-Elect throughout the bylaws
- A number of typographical, grammatical, formatting, and spelling errors were corrected
- Provisions for electronic balloting were added along with new due dates for election slates and voting periods
- Objectives of the society were updated
- A number of wording changes were made to comply with the new minimum standard bylaws
- The office of Secretary/Treasurer was separated into two positions to comply with the national standard, however the same person can hold both positions at the discretion of the Allegheny SAF Executive Committee
- Some committees were designated as special committees as opposed to standing committees, and committee descriptions were simplified
- Section J Appointments was deleted
- A required new article on Unit Position Statements was inserted as new Article 11; existing articles 11-14 were renumbered to 12-15; information on unit positions was removed from the Meetings Article as a result of this new article
- The timeframe for the Allegheny SAF meeting was changed from February to the first quarter of the year

# New Pennsylvania Home Improvement Law Might Apply to Foresters

Pennsylvania recently enacted the Home Improvement Consumer Protection Act ("HICPA"). The law is primarily focused on contractors who do work for homeowners in private residences.



However, because of the broad scope of the law, foresters, at least in some capacities may also be required to comply with certain requirements.

HICPA applies to "home improvement contractors." The definition of a home improvement contractor includes typical contractors such as plumbers, electricians, and carpenters. However, the law also includes landscapers who work with private landowners in building non-decorative fences or drainage systems when these items are constructed on a portion of a property with or adjacent to a private residence.

For foresters, this means that the law might apply to setting up a deer fence or installing culverts or other sedimentation measures on a property with a cabin. However, there has been little guidance from the state on how it will interpret the law. Because of the law's potential applicability to certain forestry operations, the relatively low cost to comply, and the penalties for non-conformance, foresters should consider addressing the requirements of HICPA in order protect your company.

# Complying with HICPA

There are two primary tasks which must be done in order to comply with HICPA. The first task is to register your business with Pennsylvania's Bureau of Consumer Protection. This process can be done online. Registration costs fifty dollars, but the registration is valid for two years.

The second task is to assure that any contracts

with private homeowners are HICPA compliant. HICPA sets forth a list of items which must (and must not) be included in a contract with a private homeowner. Failure to include these items may give the homeowner the power to void the contract. Among other items, the contract must:

- Be in writing
- Signed by both the homeowner and contractor
- Include an estimated beginning and completion date
- Include a detailed description of the work to be performed
- · A total sale price for the work
- A notice of the homeowner's right to rescind the contract within three business days
- And more...

There are also significant civil penalties for not complying with HICPA. For instance, there are substantial fines and prison terms for fraudulent or deceptive behavior by home improvement contractors. However, practically speaking, the most significant penalty for not complying with the law is the risk that a homeowner will void a contract and force the contractor to institute legal action just to collect payment for services.

Due to the harsh penalties imposed by HICPA, foresters may want to have their contracts reviewed by an experienced attorney.
